A LOCAL LAW PROVIDING FOR THE LICENSING AND REGULATION OF THE USE OF LAND FOR A DUMP; DUMPING GROUND; OR SANITARY LANDFILL; AND PROVIDING FOR UNIFORM ADMINISTRATION AND ENFORCEMENT, INCLUDING PENALTIES FOR THE VIOLATION THEREOF.

BE IT ENACTED, by the Town Board of the Town of Louisville, New York,  
as follows:

ARTICLE I TITLE - This Law shall be known as DUMPING AND LANDFILL REGULATIONS IN THE TOWN OF LOUISVILLE.

ARTICLE II PURPOSE AND SCOPE

A. Purpose

The Town Board of the Town of Louisville declares its intent to regulate in a manner consistent with the interests of the citizens of the Town of Louisville the use of lands within the Town as a dump, dumping grounds, or sanitary landfill. These uses and activities are declared to be of such nature and character as to warrant special attention in order that they not adversely affect development and the quality of life in the Town.

B. Scope

This Section shall apply to dumping or landfill operations upon all lands, private or public, within the Town, except upon such premises as are or may be lawfully established as a public dump, dumping grounds or sanitary landfill in this Town and thereon only in the manner herein provided.

ARTICLE III DUMPING AND LANDFILL REQUIREMENTS

1. No person shall use any of the lands within the Town of Louisville as a dump, dumping grounds, or sanitary landfill, nor shall any person throw, dump, deposit or place on such lands or cause to be thrown, dumped, deposited or placed on such lands any waste material or rubbish, litter or any nauseous or offensive matter, nor dispose or attempt to dispose of any such materials, substances by burying the same on such lands, or burning or incinerating the same on such lands, except at such location and in such manner as established by the Town Board.
2. No person shall deposit or cause to be deposited any substance of any kind on premises established as a public dump or sanitary landfill in the Town, except at the places and in the manner described by the person in charge of the premises under the authority of the Town Board, if such a person be so designated, or by a sign or signs erected upon the premises by the authority of the Town Board.
3. No person shall deposit or cause to be deposited on premises established as a public dump or sanitary landfill of this Town or any substance of any kind which originally was collected from outside of the Town of Louisville except as by agreement and contract with the Town.

4. No person who does not reside in the Town of Louisville may deposit or cause to be deposited any substance of any kind on the premises established as a public dump or sanitary landfill in the Town except as by agreement and contract with the Town.

#### ARTICLE IV ADMINISTRATION AND ENFORCEMENT

A. Enforcement

Enforcement of this Law shall be the responsibility of the Code Enforcement Officer as the duly authorized agent of the Town Board.

B. Violation

Any person who commits or permits any acts of violation of any of the provisions of this Law shall be guilty of a misdemeanor and upon conviction shall be subject to a fine of not more than \$250.00 or imprisonment not exceeding thirty (30) days, or by both such fine and imprisonment.

In addition to the above provided penalties and punishment, the Town Board may also maintain an action or proceeding in the name of the Town Board in a court of competent jurisdiction to compel compliance with or to restrain by injunction the violation of this Local Law.

C. Repealer

All ordinances, resolutions and local laws of the Town of Louisville or parts thereof, inconsistent with the terms and provisions of this Local Law are hereby repealed, provided, however, that nothing contained herein shall be deemed to repeal or amend any ordinances requiring a permit or license to cover any business, trade or occupation except as set forth herein.

D. Effective Date

This Local Law shall take effect on the first day of November, 1970.
