The tree at the Willson- Willson Cemetery can be removed by our crew but a piece of the fence will have to be taken down and he is concerned about who owns the property behind the cemetery for liability issues.

A sign will be ordered for the new playground that states 12 years of age and under. A piece has been broken by teenagers on pieces of the equipment meant for much younger kids.

The estimate for LED lighting for the lobby is \$1,557.00 and over the ice \$4,140.00. Supervisor Legault will discuss the changing of the lights with the Power Authority during the energy audit. LED lights have been installed outside of the Community Center with good results. NYSERDA may also help pay for the replacements. MED has been contacted about upgrading the street lighting throughout the town.

Rental of the ice is going well.

HIGHWAY SUPERINTENDENT FENLONG did not attend the meeting.

Tom Carroll asked if the Board was aware of the plans for the SH 131 land that the purchase offer has been signed for.
